

Permission to Publish

The Institute of Asian Research, a research unit of The University of British Columbia (“UBC”) distributes an academic publication called *Asia Pacific Memo* (the “Publication”). UBC requires that all contributors who wish to submit an article to the Publication complete this form, *Permission to Publish*, before their submission may be published.

In consideration of UBC's agreement to publish the Author's Work on the terms set out in this Agreement, the Author and UBC agree as follows:

1.0 Permission to Publish Granted to UBC

1.1 The Author grants to UBC a *non-exclusive*, perpetual, and worldwide license (the "License") to publish, copy, distribute, and use the Work in all forms, editions and formats, including in print or electronic form, such as e-book, e-mail, website, or any type of public display in connection with the Publication.

2.0 Agreement to Publish

2.1 UBC agrees to publish the Work at UBC’s sole expense in the form and manner as UBC in its sole discretion may determine. Before any publication, UBC has the right, at its sole discretion, to edit the Work, including the right to add to, delete from, or alter the Work, provided that, prior to publication, the Author is given the opportunity to review and consent to the final version of the Work to be published in the Publication as the Author’s contribution and with credit for the Work being attributed to the Author. The terms of this Agreement shall apply to the final version of the Work that is published in the Publication, **a copy of which is attached to this Agreement as Schedule "A"**.

2.2 The Author acknowledges that UBC retains the right, at any time and at its sole discretion, to decline to publish the Work in the Publication or, if UBC determines appropriate at its sole discretion, to remove the Work from the Publication.

2.3 The Author acknowledges that UBC’s agreement to publish the Work as set out above is the sole consideration to the Author in return for all of the rights granted to UBC under this Agreement, and that UBC will not pay any fees, royalties or any other amounts to the Author in connection with the Work, its publication or this Agreement.

2.4 The Author will retain all copyright in his or her Work published in the Publication under the terms of this Agreement.

3.0 Author’s Warranties and Indemnity

3.1 The Author warrants that he/she is the sole owner of all right, title and interest in the Work, and that he/she has the full power to grant the License to UBC and to enter into and perform this Agreement.

3.2 The Author further warrants that:

- (a) the Work does not infringe the copyright or other proprietary right of any other person;
- (b) the Work contains no libellous, defamatory or unlawful content;
- (c) the Work does not invade the privacy or other personal rights of anyone; and
- (d) all statements in the Work purporting to be facts are true.

3.3 The Author will advise UBC of any material(s) in the Work (either text or graphic) which belongs to others and the Author will be solely responsible for obtaining permission in writing from the owner(s) of such material(s) for its inclusion in the Work and for use in connection with the Publication as set out under the terms of this Agreement.

3.4 If any claim is made against UBC based on a breach of the Author’s warranties as set out above (a “**Claim**”), then UBC will notify the Author of the Claim, provided that all decisions regarding the defence of the claim (including settlement) will be made by UBC.

3.5 The Author agrees to indemnify UBC against any costs (including UBC’s legal costs), damages or losses incurred by UBC as the result of any Claims or any other breach by the Author of this Agreement.

4.0 General

4.1 This Agreement is governed by the laws of British Columbia. This Agreement constitutes the entire agreement of UBC and the Author regarding the Work. No amendment to this Agreement is valid unless in writing signed by UBC and the Author. This Agreement is binding on UBC, the Author, and the Author’s heirs, administrators and personal representatives.
